

In Cases of Sexual and Interpersonal Violence Students have the right:

- 1. To report to the police;
- 2. To have Stony Brook take your report seriously;
- Not to be pressured by Stony Brook to report or participate in any investigation or process;
- For Stony Brook's process to be fair, impartial and provide an opportunity to be heard;
- 5. To be treated with dignity and to receive from Stony Brook courteous, fair and respectful healthcare and counseling services;
- 6. To report free from the suggestion that you should have acted differently or that you are at fault;
- Not to be required to unnecessarily repeat your account of the incident;
- 8. To be protected from retaliation;
