SUBJECT: President's Report

I. COVID-19 MATTERS

Below are noteworthy updates and actions related to our COVID-19 efforts:

• SUNY Policy on Pre-Thanksgiving Break Testing

Chancellor Malatras recently announced a <u>new SUNY system-wide policy</u>, which mandates all students using on-campus facilities in any capacity to test negative for COVID-19 within the 10 days prior to leaving campus. The policy also strongly recommends that faculty and staff get a test during the same period.

Pooled Testing

Faculty, staff and non-resident students who come to campus are now required to do saliva pooled COVID-19 testing. Feedback to date has been positive and those tested have noted it is a quick, easy process. Additional testing sites have been added at the Southampton Campus and Health Science Center and pooled saliva testing is also beginning for Stony Brook University Hospital employees. • Dr. Deborah Birx Visits Stony Brook

Dr. Deborah Birx, head of the White House Coronavirus Task Force, visited Stony Brook University on October 7. In a series of meetings, Dr. Birx met with University leadership, researchers, students, and members of the COVID Response Team. She received an overview of Stony Brook's response to the virus, including campus policies and medical research. Dr. Birx praised the University's success in controlling the spread of COVID-19 and emphasized steps that can be taken to help keep case numbers low in the future. She stressed the need for enhanced surveillance in order to head off any possible resurgence in the community. She also warned of a likely resurgence of the disease in the Northeast in the fall and noted that this will be driven by smaller events like family gatherings. Dr. Birx also emphasized the importance of masks and physical distancing as residents move indoors during the colder months.

II. LEADERSHIP UPDATES

Charlie Robbins Steps Down

Dr. Charlie Robbins has stepped down as Vice Provost for Undergraduate Education and Student Success & Dean of the Undergraduate Colleges. During the past decade, Charlie has been an invaluable member of the senior leadership team and worked tirelessly to transform and enhance the academic experience of all undergraduate students. Charlie's touchstone accomplishment during his tenure was improving student success metrics through his work on the Academic Success Team and the Male Completion Team. His unwavering dedication and service have had a major impact on the lives of countless students.

III. UNIVERSITY ACCOLADES

SBUH Named America's 100 Best for Cardiac Care, Coronary Intervention and Stroke Care

Stony Brook University Hospital (SBUH) has once again earned national recognition for its programs that provide stroke care, cardiac care, and coronary intervention. It is the seventh year in a row that SBUH was named by Healthgrades as one of America's 100 Best Hospitals[™] for Cardiac Care, and the sixth consecutive year that SBUH has been named one of America's 100 Best Hospitals[™] for Coronary Intervention and Stroke Care.

IV. ADVANCEMENT UPDATE

Since the start of the 2021 fiscal year, \$7 million has been generously pledged or donated by 3,600 donors investing in our students, our faculty/staff, and our patients, to elevate Stony Brook's extraordinary strengths in research, medicine, technology, engineering, arts, the humanities and social sciences. Generous contributions since the last update include:

- Stony Brook's second annual Giving Day was a success with 2,500 donors raising \$362,000. Forty-eight matching challenges were fulfilled to benefit more than 29 areas across campus, with \$216,400 raised for the Colleges and departmental projects. Alumni led the way in giving, making 41 percent of the 2,900 gifts to the fundraising drive.
- \$1.7M planned gift intention for Computer Science.
- \$500,000 pledge toward an Endowed Professorship in Gastroenterology.
- \$300,000 gifts and pledges toward an endowed research fund in Chemistry.
- \$290,000 to support undergraduate student scholarships.
- \$125,000 pledge toward an Endowed Lectureship Award in Chemistry.
- \$100,000 pledge toward an endowed student scholarship in Computer Science.
- \$50,000 toward the CAR-T Cancer Therapy Program.

V. ELECTION DAY RESOURCES

With Election Day around the corner, many efforts have been made to engage and prepare our community. The University recently launched a <u>Caring, Respect and Civility website</u>, which provides information on upcoming events, free speech, internal and external resources, along with

news and updates. A special edition of the Beyond the Expected podcast series, "Election 2020: Preparing for the Day After" will air on Facebook Live on November 2 at 1:00PM. In addition, the Center for Civic Justice has held virtual presidential debate viewing sessions and offers a wealth of voting resources on its <u>website</u>. We also recently sent out a set of resources to provide you with some tools and guidelines to help you manage your classes and support your students, colleagues, and yourselves over the coming weeks.

IX. ATHLETICS UPDATE

- The men's and women's basketball teams will open the season on **Wednesday**, **November 25** the first permissible date of competition as set by the NCAA. In order to mitigate travel, America East conference games will be played in a format that consists of weekend series, where a team hosts the same opponent on back-to-back days for two games. With no fans expected to be permitted to games in Island Federal Arena, the "My Seawolves Cutout" program will allow supporters to purchase a cardboard cutout that will be placed in a seat location.
- Football will play a six-game conference schedule in the spring, beginning with the home opener at LaValle Stadium on March 6 against Villanova.
- Stony Brook Athletics launched the "Believe In The Seawolves" campaign on October 8 to coincide with the University-wide Giving Day. Including a \$100,000 commitment, the year-long campaign has generated over \$200,000 from supporters thus far.
- The Black Student-Athlete Huddle partnered with the Stony Brook Chapter of the NAACP to hold a rally for social justice outside of the Staller Center on Wednesday, October 21.
